Sub:- Admission/continuation of staff ward after the retirement and Untimely demise of Staff:-reg.

Sir,

Reference may be made to NVS Letter no.F.7-3/97-NVS(Acad) dated 20.7.1999 regarding admission of staff ward in JNVs which reads as:-

"1.The children admitted stands withdrawn in case of the repatriation/resignation/removal of the parent from the Vidyalaya. In such cases the continuation of the child upto the end of the academic year on the basis of the recommendation received from the Regional Officer concerned is considered by the Samiti. However, the continuation of such children in JNVs beyond Academic session is not being permitted.

2. In order to help the education of wards of employees of JNVs when the death of the parents occur while they are in service of Samiti, it is decided that such of the children who are already studying in JNVs at the time of the death of concerned parents are permitted to continue their studies free of cost, in the same manner that they would have continued, had their parent continued in service."

References were received by this Office with a request to admit/continuation of wards of retired employee as well as untimely demise of the staff. The same was considered in 34th Meeting of Executive Committee of NVS held on 27.6.2016 as welfare measure to the staff.

In this context, the approval of the Executive Committee of 34th Meeting held on dt.27.6.2016 and communicated vide letter no.1-3/2015-NVS(GA)/456 dated 25.7.2016 is conveyed as below:-

1. To permit children to avail free education facility in JNVs after retirement of employee. The permission includes admission/continuation of staff ward after retirement.
2. To permit the admission of staff wards in JNVs, even if the wards were not studying in JNV, at the time of untimely demise of the employee concerned.

You may direct the JNVs to refer such case to ROs for approval and permission may be given at Regional office level after verifying the information.

This issues with the approval of the competent authority.
